Testimony in support of Senate Bills 549-554

Chair Irwin, Majority Vice Santana, Minority Vice Chair Lindsey, and members of the Senate Housing and Human Services Committee.

Thank you for the opportunity to submit written testimony in support of Senate Bills 549-554. It has been a privilege to work over the past seven months with the dozens of groups that were part of Senator Chang's stakeholder process that built consensus around the water affordability bills pending before this committee. The Natural Resources Defense Council (NRDC) strongly supports this legislation, which paves the way for all Michiganders to secure safe and affordable water.

I've worked for many years to ensure the drinking water coming out of our taps is safe to drink and the wastewater and stormwater were cleaned up before returning to the ecosystem and our drinking water sources. However, it wasn't until the past decade that I began working with the People's Water Board Coalition and its partner groups to help secure safe <u>and</u> affordable water - because no one should have to choose between the two.

In 2020, for the first time, the Michigan legislature acknowledged that residents were struggling to pay their water bills when lawmakers included \$25 million in CARES Act funding in a supplemental appropriation (SB 690/PA123 2020) for a short-term water assistance initiative to help erase past due balances on customer water bills. Attached to this testimony is a document containing data I received from the Michigan Department of Health and Human Services (DHHS) pertaining to the \$25 million grant program. In this document, I summarized the DHHS water assistance initiative data from the Michigan community water systems that applied for a share of the \$25 million in funding. If water systems in your district are missing from the list, it could be that they did not apply for funds through this program since there are roughly 1,400 community water systems in Michigan and only 144 applied for funding.

The results of NRDC's 2020 analysis indicate that 317,631 households representing approximately 800,000 Michiganders were behind on their water bills in just these 144 water systems. Of these households, only about 37% qualified for the grant program (based on

Supplemental Nutrition Assistance Program eligibility). Only about 10% (144 of 1,400) of Michigan's water systems applied for funding and only roughly 37% of the households in those communities were eligible, yet the \$25 million appropriation was fully allocated within approximately two months of DHHS opening the grant process.

Thanks to the \$25 million short-term water assistance initiative appropriated by the legislature in 2020, we collected these data showing for the first time the statewide nature of Michigan's water insecurity problem.

The bills before this committee create a permanent water affordability program by making sure water bills are affordable on an on-going basis for eligible residents. Community groups, water utilities, service providers, environmental groups, and others worked hard to craft this landmark legislation that helps ensure residents can pay affordable water bills while also ensuring cities, townships, and villages throughout the state are not losing revenue that is critical to operating their water systems.

Thank you again for the opportunity submit testimony to the committee and thank you to Senator Chang and the other bill sponsors for leading this important water affordability legislative effort. If enacted, these measures would make Michigan the national leader in addressing the water affordability crisis. We strongly urge you to support these bills and to urgently move this legislation forward.
